FAOs

- How do I join NAIOP Corporate? You only need to pay once.
 The dues are inclusive of the Charlotte Chapter and national membership. Join today: https://naiop.org/Membership/Join.
- What type of membership do I qualify for? Principal members
 are individuals whose primary business is development, ownership,
 asset management or investment. Associate members are those
 who provide products or services to the industrial, office, mixed-use
 or related commercial real estate firm. Discounts are available for
 multiple persons from a firm.
- What is a Devloping Leader? You qualify if you are 35 years or younger and are a developer, owner, investor, asset manager or provide services in commercial real estate.
- How are my future dues calculated? NAIOP dues are for 12 months of membership. When you join, you pay for 12 months. On your first anniversary, you will receive a prorated dues invoice to update your dues to a calendar year billing.
